Services Provided

Terms and Conditions

- **TERM AND TERMINATION**

This Agreement will take effect on _____, and will terminate automatically on _____. Either party may terminate this Agreement earlier whether a violation has been committed or not by providing at least thirty (30) days' written notice to the other party.

- **FINANCIAL TERMS AND CONDITIONS**

The Website Owner agrees to pay the Sponsor five hundred dollars (\$500.00), per sponsored content, for the continuity of the promotion work of Sponsor subject to the terms and conditions of this Agreement.

- **NON-FINANCIAL TERMS AND CONDITIONS**

Neither Sponsor nor the Website Owner will provide sponsorship or promotional work relevant to a “Direct Competitor” of the other party. In this connection, Sponsor and Website Owner are bound by this Agreement to be exclusive sponsors and promoters of the either as the Parties’ respective websites.

- **CONFIDENTIALITY**

Sponsor and Website Owner will maintain and uphold the confidentiality of the Agreement, including but not limited to schedules, exhibits, business and marketing plans, and other financial information or written materials.

- **INDEMNIFICATION**

Both Parties hereby agree to indemnify, hold harmless, and defend the other party from and against any kind of claims, suits, demands, or threats associated with respect to certain costs such as attorney fees and court costs arising from the infringement of any party included in this Agreement or any proprietary rights. Sponsor, Website Owner, or any other third party entity holds such as patents, copyrights, trademarks, and/or any other claims thereof.

- **INDEPENDENT CONTRACTORS**

Both Parties agree that this Agreement will not be construed as a joint venture, partnership, agency, employer-employee association, or any legal relationship other than independent contractors. Neither party will act as a representative of the other.

- **GOVERNING LAW**

This Agreement will be construed and enforced in accordance with the laws of California.
